

- That Sansktiti School is run by The Civil Services Society under the Registration Act XXI of 1860 vide no. S/27420 of 1995 dated 7th February, 1999.
- 2. That the Sansktiti School is of Non-Proprietary Character
- That the School is being run as not for profit and not at a business and that commercialization does not take place in the School in any manner whatsoever.
- 4. That no part of income from the institution is being and will be diverted to any individual in the Trust/Society/School Management Committee or to any other person/entity. The saving, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, Depreciation and contingency funds, will be further utilized for promoting the School and extending the cause of education in the same school only.
- 5. That the School is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body.
- 6. That the School will not open classes under CBSE pattern particularly Class IX/X/XI/XII and will not use CBSE name in any manner without obtaining affiliation.
- 7. That the undersigned of the School have individually gone through the provisions contained in the affiliation and examination bylaws and the circulars issued by the Board from time to time. The School undertakes to abide by the provisions contained in the affiliation & examination bylaws, directions issued from time to time and the law of the land.
- That the School will ensure compliance of all statutory requirement like EPF etc. with respect to the School and staff of the School.
- That the School will ensure that the Building Safety, Fire Safety, Water Safety, Health and Hygiene Certificate are being issued or renewed by the concerned Municipal or State Authorities from time to time as per the prescribed term school before starting classes.
- 10. That the School will ensure that all required infrastructures is available with the School before starting classes.
- 11. That the School will ensure that sufficient number of qualified teachers as per the provision contained in affiliation by-laws are available with the School before starting classes.
- 12. That the School will follow the provision related to fee contained in affiliation by-laws and will disclose the details of the fee to the students / parents every year before start of session without resorting to any hidden charges in the heads of the fee.
